

## TAX DEDUCTIBILITY

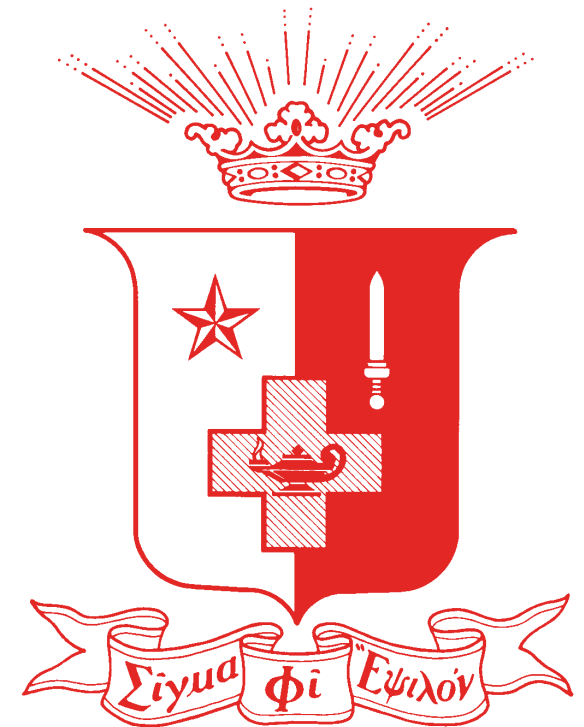
