# Indiana Alpha Becoming Model for Recolonizations, Alumni Engagement

#### AVC Reflects on 2018 Improvements

Brothers, as the Alumni Volunteer Corporation (AVC) reflects on the accomplishments of the past year to gauge the health of the organization, we understand how our actions are cultivating more strength for the Indiana Alpha Chapter of Sigma Phi Epsilon.

In this time period without an active undergraduate chapter, our success is measured in increased alumni engagement. For instance, we have spent time partnering with Pennington & Company to update and correct our alumni database, resulting in nearly 1,700 database fields updated between the dates of November 1, 2017, and October 31, 2018. In contrast, only 183 fields were updated for the year of 2016-17 when we managed the membership updates on our own. Our annual campaign welcomed 20 alumni as first-time donors and more than 30 renewed their giving after a two-year or more lapse. Also, in support of building out the mentoring board for the chapter redeployment, we have received more than 15 alumni to-date interested in helping. Finally, the attendance soared from two guests to 22 guests from 2017 to 2018 at our annual Alumni Homecoming Banquet.

The message is clear: Indiana Alpha is rising from the ashes to be strong, sustainable, and a model for other chapters to follow. Recently, your board members were approached by alumni from other chapters who faced similar circumstances. They wanted to learn from our approach of engaging alumni and working together to rebuild our chapter.

We recognize that we have a long road ahead of us rebuilding the chapter, but we also want to take time to celebrate the accomplishments and invite the alumni group to be a part of the movement. #### **Directors of New Chapter Development Reflect on Recolonization Mission**

In 1901, our founders made the promise, "This Fraternity will be different." Today, SigEp is different, and we have the privilege of bringing that difference to life at Purdue. From the way our members interact and grow, to the way we engage with a chapter facility, faculty, and staff on campus, and to the way we recruit, we are different. Yet, our mission is the same: building balanced men through the principles of virtue, diligence, and brotherly love in one of the most formative times of life to build the habits that lead to a lifetime of fulfillment.

As we continue our work on campus, we want to give you some insight into how some of those differences are coming to life at Purdue.

#### 1. Member Development: The Balanced Man Program

The Balanced Man Program has a foundation that thrives in a culture of equal rights and responsibilities, continuous development, accountability, values-based actions, and mentorship. From the moment someone accepts an invitation to join SigEp, they are welcomed as a full brother. Brothers immediately engage in a growth model that will last the duration of their time in college with peers to hold them accountable, ritual rites of passage to shape their moral compass, and mentors to push them further than they could have imagined.

#### 2. The Chapter Facility: A Substancefree SigEp Learning Community

Through substance-free learning communities, we create an environment where brothers can build relationships rooted in mutual values, growth, and fun that does not jeopardize our well-being. SigEp also seeks to be a true partner in higher education. We welcome faculty, staff, and students regardless of their affiliation into our facilities where we can intentionally advance the student experience in ways that simply do not happen in the classroom.



New members participate in open dialogue and exercises led by SigEp's new chapter development directors. The national staff members will remain on campus throughout the semester to continue recruiting and training our new undergraduate members.

#### 3. Recruitment: Year-Round through the Balanced Man Scholarship

Through the Balanced Man Scholarship, we learn about an individual's motivation in coming to Purdue, the values that guide them, and the legacy they look to leave on campus. It is a rare occasion when those motivations, values, and legacies do not align with SigEp's values. Through intentional, values-based conversations, we ask those young men to join our organization whenever the time is right, whether that be in the first week on campus, the middle of the semester, or the day before finals.

#### Your Chapter: SigEp at Purdue

We are proud to say that we have 16 exceptional young men, and counting, who will be building a new SigEp legacy at Purdue. This group boasts a 3.68 GPA and features a diverse set of experiences with members from Indiana, Illinois, Michigan, Kentucky, California, Colorado, and Hawaii. Collectively, they are pursuing majors within the colleges of engineering, science, management, liberal arts, the polytechnic institute, pharmacy, and health and human sciences. On top of their studies, almost all serve on the executive board for at least one other organization on campus.

As membership grows, we are finding that more students want an experience that places just as much emphasis on their personal growth as it does the growth of the chapter. Students want an experience that is void

> of pledgeship and hazing, an experience where they can be inclusive and proud of their facility and an experience in which they can be the best versions of themselves.

### THE NEW PERSON-CENTRIC HEALTHCARE SYSTEM

or the last 20 years I have been working on a national level with the clinical technology HITECH programs backing up President Bush's 2004 Executive Order and President Obama's 2009 HITECH Act. These two programs established the Sub Cabinet National Office of the Coordinator of Health Information Technology

(HIT). The objective and outcome of the program is the digitizing of HIT. This leads to the new healthcare system of Person Centric eLongitudinal Valued Care with an emphasis on wellness and prevention. In 2004 I was asked by then Secretary of HHS Tommy Thompson to coordinate Long Term Care HIT. I have served on many federal and other committees representing Long Term and Post-Acute Care (LTPAC).

In a short article it is difficult to go into depth on all the legislation and regulations that have or will be passed and implemented to get to our final goal. Basically, it is changing our system from a fee for service to a valued outcome system. Another way to say this is going from an episodic system where a person has an incident and gets fixed to a system that has a focus on quality of life and prevention of incidents.

Why is this important to you? First, you as an individual and your loved ones have to be more involved in your healthcare. The government and private companies like Apple will be providing you tools to help especially elderly persons requiring chronic care. The tools and payment models will be based

on sharing risks. They will also have to be longitudinal. All health, social, and environmental aspects of an individual will be monitored over time and aggregated for normals. Clinical Decision; Cognitive, AI, IBM Watson, etc. software will be used.

We will also be added by Precision Medicine, which is the study of genomics

and DNA. We have to get healthcare down to the individual's requirements to ensure the best quality of life at a reasonable cost. This can only be done by persons assuming some responsibility for their own health and working with their clinical team. Persons who smoke, are obese, use drugs, and in other ways don't take care of themselves have to change their habits and focus on their own health and not depend to be fixed after having a health incident.

Bottomline, the healthcare systems are changing to a focus on you as an individual and to succeed you and your love ones have to become more involved in your health. The result is a higher quality of life.

Brother Derr is a Purdue Distinguished Alumnus (2006), Old Master, and received the Old Indiana Alpha Distinguished Alumnus Award. He is a director of the Purdue University Los Angeles Alumni Association and served on the Purdue School of Pharmacy Dean's Advisory Board for over 15 years.
